Our mission is to Cleanse the Oceans of Plastic Pollution. We spread awareness of the plastic pollution crisis through our community educational programs and our media platforms, and we collaborate with local community organizations to provide our extensive Student Internship Program. Our innovation for marine cleanup is our Floating Robot for Eliminating Debris (FRED), a solar-powered, semi-autonomous unmanned robot capable of collecting marine plastic debris, scientific data, and environmental samples.

Clear Blue Sea is implementing a Phased Program Development methodology to ensure our marine robot FRED is well-designed, easily constructed, and readily maintainable. Having already built and demonstrated two 6-foot FRED prototypes, we are currently at the end of Phase II of our FRED Prototype Program, which will implement a mid-scale, operational FRED Prototype for ocean cleanup across multiple San Diego marine environments. In parallel with the final development of this mid-scale FRED, Clear Blue Sea plans to document the small-scale FRED in the public domain for use by all interested parties. Phase III fleet will include Clear Blue Sea's 50-foot FRED plus all the small-scale FREDs built and customized by communities around the world. In 2019 we mentored 100+ students through our internship program, teaching STEM and project management through FRED prototyping projects.

Purpose of Schedule

An organization should use Schedule O (Form 990 or 990-EZ), rather than separate attachments, to provide the IRS with narrative information required for responses to specific questions on Form 990 or 990-EZ, and to explain the organization's operations or responses to various questions. It allows organizations to supplement information reported on Form 990 or 990-EZ.

Don't use Schedule O to supplement responses to questions in other schedules of the Form 990 or 990-EZ. Each of the other schedules includes a separate part for supplemental information.

Who Must File

All organizations that file Form 990 and certain organizations that file Form 990-EZ must file Schedule O (Form 990 or 990-EZ). At a minimum, the schedule must be used to answer Form 990, Part VI, lines 11b and 19. If an organization isn't required to file Form 990 or 990-EZ but chooses to do so, it must file a complete return and provide all of the information requested, including the required schedules.
