During 2019 and 2018, respectively, 4,046 and 3,517 teachers were trained on-site, online, and through distance learning opportunities, which represents 6,898 and 5,768 enrollments during 2019 and 2018, respectively. In 2019, Neuhaus Family Support Office received 3,261 contacts from parents and family members concerned about dyslexia and reading difficulties in their children. The Teacher Professional Development Program consists of approximately thirty classes in the areas of Phonemic Awareness; Instant Letter Recognition; Sequencing and Decoding Skills; Listening/Reading Comprehension; Scientific Spelling; Multisensory Handwriting, Grammar, Syntax, and Paragraph Structure; and Oral Language Development. Also, teachers are offered classes on how to apply the results of various intervention studies on metacognitive skills, language enrichment, and literacy for their readers.
